

Ordinance No. 2015-06

AN ORDINANCE AMENDING RATES AND CHARGES
FOR THE USE OF THE WATER SYSTEM FOR TEMPORARY AND/OR SPORADIC
USAGE AND RELATED SERVICES OF THE TOWN OF WOLCOTT

WHEREAS, Indiana Code Section 8-1.5-3-8 requires that the Town of Wolcott (“Town”) on behalf of its Water Utility establish rates and charges which will produce an income sufficient to maintain the utility property in sound physical and financial condition to render adequate and efficient service; and

WHEREAS, said Code section requires that rates and charges shall be collected from the owners of each and every lot, parcel of real estate or building that is connected with the Town water system; and

WHEREAS, the Wolcott Municipal Utilities receives, from time-to-time, requests for water service from a customer (who is not connected with the Town’s water system) for temporary and/or sporadic water service for extraordinary usage, i.e., commercial, agricultural, recreational, etc.; and

WHEREAS, said temporary and/or sporadic water service is provided from a hydrant specified by the Water Superintendent, and equipped with a back flow valve and water meter;

WHEREAS, the Town Council of the Town wishes to amend Ordinance No. 2009-03, Wolcott Municipal Utilities – Water Services, paragraph entitled, “Water Charge for Out-of-Town Usage”.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WOLCOTT, INDIANA:

Section 1. That Ordinance No. 2009-03, Wolcott Municipal Utilities – Water Services, paragraph entitled, “Water Charge for Out-of-Town Usage”, shall be amended as follows:

TEMPORARY AND/OR SPORADIC WATER SERVICE FOR
EXTRAORDINARY USAGE

Water which is purchased from the Wolcott Municipal Utilities for water service from a customer (who is not connected with the Town’s water system) for temporary and/or sporadic water service for extraordinary usage, i.e., commercial, agricultural, recreational, etc., and is not “tapped” into the water utility system, and water service is provided from a hydrant specified by the Water Superintendent, and equipped with a back flow valve and water meter, will be charged two (2) times the 2” meter rate for gallonage used.

Section 2. All other provision of all other rates and charges established by the Ordinance shall remain in full force and effect.

Section 3. This ordinance shall be in full force and effect from and after its passage.
